2. Attach the following supporting documents:
  - 1) Photocopy of NRIC (Singaporeans / PRs) or IC (Malaysians) or passport (other foreigners)
  - 2) Original or E-statement dated within the last 3 months which cross-references IC / passport particulars (any one of the following):
    - a) Bank statement from any Monetary Authority of Singapore (MAS) licensed bank; **OR**
    - b) Central Provident Fund (CPF) statement (available on CPF website); **OR**
    - c) Latest Notice of Assessment for Income tax (Available on IRAS website)

Note: These documents will be retained by CDP.
